Artists sell reproduction rights, or a licence, for a specific limited purpose; the artist retains copyright and can continue to profit from it. For example, the artist sells the image for use on a set of table mats, but can then go on to sell it for other uses.

Artist's Resale Right gives creators of original works across their lifetime, and for 70 years after their death, the right to a payment when their work is resold in the secondary market with the involvement of an art market professional. The rules, which came into force via an EU directive in 2006 updated in 2011 (see box, below), apply to works sold in the UK or another country in the European Economic Area (EEA) by an artist in the region.

If you're an independent artist you'll have control over your sound recording copyright, and if you approve of this use you can negotiate the fee the other party would need to pay to secure the right to use your recording. If you hold the rights to both the composition and the sound recording you can grant permission for the use of both.
